## REGISTRATIONS

### **C. DOE Office of Science Portfolio Analysis and Management System (PAMS)**

Notifications sent from the PAMS system will come from the PAMS email address <[PAMS.Autoreply@science.doe.gov](mailto:PAMS.Autoreply@science.doe.gov)>. Please make sure your email server/software allows delivery of emails from the PAMS email address to yours.

Registering to PAMS is a two-step process; once you create an individual account, you must associate yourself with (“register to”) your institution. Detailed steps are listed below.

#### **1. CREATE PAMS ACCOUNT:**

### **SUMMARY**

The Climate and Environmental Sciences Division (CESD), Office of Biological and Environmental Research (BER) of the Office of Science (SC), U.S. Department of Energy (DOE), in collaboration with the Amazonas Research Foundation and the São Paulo Research Foundation of Brazil, hereby announces its interest in collaborative grant research applications in support of the upcoming GreenOceanAmazon2014 experiment (GOAmazon2014).

## SUPPLEMENTARY INFORMATION

Tropical deep convection in its natural state and the underlying processes that drive it are poorly understood and modeled, often with insufficient observational data sets to advance either a scientific understanding or modeling capabilities. Given the current state of the science, the Office of Biological and Environmental Research's Climate and Environmental Sciences Division (CESD) will provide support to the community to conduct a major field experiment to advance the scientific understanding of coupled atmosphere-cloud-terrestrial tropical systems.

The field experiment, i.e., GreenOceanAmazon2014 (hereinafter referred to as GOAmazon2014) (<http://www.arm.gov/campaigns/amf2014amazon>), will extend through the wet and dry seasons for a one-year period, January 1 - December 31, 2014, with planned extensions through 2015. The Department of Energy's ARM Climate Research Facility, Environmental Molecular Sciences Laboratory, and Terrestrial Ecosystem Science Program will provide support for observational resources to be deployed in the Amazon Basin. In 2014 and 2015, both the ARM Mobile Facility (AMF) and ARM Aerial Facility (AAF) airborne platform will be on location near Manaus, Brazil for the GOAmazon campaign. Under this FOA, the Atmospheric System Research, Regional and Global Climate Modeling, and Terrestrial Ecosystem Science programs will support research using data collected as part of GOAmazon to evaluate and improve the representation of these coupled processes in the climate models.

The scope of GOAmazon is derived from scientific questions involving interactions and interdependencies involving atmospheric, terrestrial ecosystem, and carbon cycle processes, from both an experimental and modeling context, yet applicable to tropical systems in the Amazon. More specifically, the GOAmazon experiment will address how aerosols and surface fluxes influence cloud cycles under clean conditions, as well as how aerosol and cloud life cycles, including cloud-aerosol-precipitation interactions, are influenced by pollutant outflow from a tropical megacity. Observations will provide a data set vital to constrain tropical rain forest model parameterizations for organic aerosols, cloud and convection schemes, and terrestrial vegetation components, and evaluate how process interactions are perturbed by pollution.

In view of the mutual interest in the GOAmazon science goals of both U.S. and Brazilian science agencies, this FOA is coordinated with announcements issued from the Brazilian state research funding agencies FAPEAM (Fundação de Apoio à Pesquisa do Estado do Amazonas, or Amazonas Research Foundation) and FAPESP (Fundação de Apoio à Pesquisa do Estado do São Paulo, or São Paulo Research Foundation). **As described in the Collaboration section below, applications submitted in response to this FOA must be collaborative with a Brazilian research scientist employed by an institution qualified to submit proposals and receive funding from either FAPEAM or FAPESP. Applications must be truly collaborative in the conduct of research, including definition of goals, approach, and work plan; separate budgets must be submitted in which the DOE is clearly distinguished from the Brazilian component.**

The Department of Energy, Office of Biological and Environmental Research hereby announces its interest in receiving applications for research from scientists employed at eligible institutions in support of GOAmazon, whereby the proposed project also includes a collaborating Brazilian research scientist. The Brazilian collaborator must be qualified to submit the same proposal to the Brazilian states of Amazonas and/or São Paulo. The proposal submitted by Brazilian researchers to their respective state agencies will be evaluated for funding from their respective states, and the DOE-eligible researchers will be evaluated for funding from DOE as per the guidance issued with this FOA.

### **BER Programs and Research Topics:**

The three BER research programs will support research topics according to their individual missions and research interests, as follows:

**Atmospheric System Research (ASR):** The goal of the [Atmospheric System Research \(ASR\)](#) program is to improve the treatment of clouds, aerosols, and radiative transfer processes in atmospheric models, that in turn are combined with ocean, terrestrial, and ice sheet models to make projections of climate change. Background material on ASR science is available through the [ASR Science Plan](#). The ASR program utilizes the long-term cloud, aerosol, precipitation, and background meteorological data sets from the ARM Climate Research Facility, a unique climatic observational database that is in turn used to advance the predictability of regional and global climate models. For this solicitation, ASR will consider research proposals for tropically-relevant science in the context of the GOAmazon campaign.

ASR research emphasizes three overlapping subjects of scientific inquiry: cloud life cycle; aerosol life cycle; and cloud-aerosol-precipitation interactions. For cloud life cycle research, themes of research interest include retrieval of cloud micro and macrophysical properties in the context of long term climate records, and analysis of cloud properties and their interactions with atmospheric radiation from a climate perspective. For aerosols, ASR focuses on extending the science so that physical, chemical, and biogenic aerosol processes become sufficiently advanced so that they are adequately represented in climate models. The third subject is Cloud-Aerosol-Precipitation-Interactions, including the quantification of indirect effects of aerosols on clouds and associated processes such as precipitation. ASR strives to extend process level research towards improvement or development of formulations suitable for regional and global climate models. For this solicitation, ASR will consider research proposals for tropically-relevant science in the context of the GOAmazon campaign. ASR specifically encourages applications in the following specific Science Areas:

- Improved understanding of the life cycle of aerosols in the Amazon basin during the GOAmazon 2014-2015 timeframe, including the interaction of pristine and polluted air masses.
- Improved understanding of the interaction of aerosols and clouds over the Amazon basin, including aerosol impacts on precipitation and tropical convective processes, as well as cloud impacts on aerosol transport, chemistry, and removal.
- Improved understanding of the evolution of tropical convective systems in the GoAmazon domain and the processes driving these transitions.

**Terrestrial Ecosystem Sciences (TES)**: The goal of the TES program is to improve the representation of terrestrial ecosystem processes in Earth system models thereby improving the quality of climate model projections and providing the scientific foundation needed to inform DOE's energy decisions. TES uses a systems approach to understand ecosystems over multiple scales that can be represented in models (e.g., single process models, ecosystem models, and coupled Earth system models). This emphasis on the capture of advanced understanding in models has two goals. First, it seeks to ultimately improve the representation of these processes in coupled models, thereby increasing the sophistication of the projections from those models. Second, it encourages the community to exercise those models and to compare the results against observations or other data sets to inform future research directions. Current information on the TES program can be found at <http://science.energy.gov/ber/research/cesd/terrestrial-ecosystem-science/>.

The TES program will consider applications designed around measurements, experiments, modeling and synthesis to provide improved quantitative and predictive understanding of tropical ecosystem processes in tropical forests that can affect changes in atmospheric greenhouse gas concentration and thereby affect forcing of climate. The emphasis of this FOA topic is to understand the feedbacks from terrestrial ecosystems in response to a changing climate. Applicants should pose their research goals, objectives, and approach in the context of representing terrestrial ecosystem processes in Earth system models. The emphasis on applicability to models can be accomplished through process research that specify mechanisms for the incorporation of results into state of the art process, ecosystem or Earth system models, by proposing direct improvements to such models or through synthesis activities that draw on existing data sets. DOE does not study the effects of specific management practices (e.g., agricultural processes). However, we recognize that land use change is a major driver of change in tropical ecosystems. As such, DOE is willing to consider research questions that address fundamental ecological processes associated with land use change (e.g., soil carbon response to reforestation following land clearing).

TES will consider research proposals for tropically-relevant science that falls within the program's scope and encourages applications in the following specific Science Areas:

- New or improved understanding of the drivers and feedbacks of drought and related natural disturbances on tropical forests. Particular emphasis is placed on hydraulic properties, understanding of temperature thresholds and sensitivities of photosynthesis and respiration, and forest carbon allocations.
- Improved understanding of belowground processes and mechanisms across scales associated with a changing climate in the Amazon basin. Particular emphasis is on plant, mycorrhizal and soil biogeochemical processes impacted by changes in temperature, precipitation, and carbon allocation.
- Improved understanding of physiological and environmental factors (e.g., light quality) that control the cycling of carbon and nitrous oxides through tropical forest ecosystems.
- Research is also sought to provide a robust understanding of fungal derived aerosols and their interactions with atmospheric processes beyond the vegetative canopy.

All projects should clearly delineate an integrative, hypothesis-driven approach or synthesis activity and clearly describe how the results of the research will improve our ability to understand and predict the role of the terrestrial ecosystems in a changing climate.

Applicants are encouraged to consider utilization of, or collaboration with, sites that have existing support (e.g., existing AmeriFlux projects, <http://ameriflux.lbl.gov>), thereby leveraging ongoing investments, archived samples and long-term data sets.

Applicants are encouraged to employ a model-inspired approach to pose their research questions, which in turn provides a direct link to improving the model or process representation. Given extensive efforts by DOE to develop the Community Earth System Model (CESM) (<http://www.cesm.ucar.edu/>), including the Community Land Model (CLM), applicants are encouraged to link their activities to these efforts where appropriate.

**Regional and Global climate Modeling (RGCM):** The goal of the RGCM program (<http://science.energy.gov/ber/research/cesd/regional-and-global-modeling/>) is to advance the predictive understanding of Earth's climate, its variability, and change by focusing on analysis of regions critical to climate; evaluating robust methods to obtain higher spatial resolution; and diagnosing and analyzing state-of-the-science for coupled climate and Earth system models to understand climate variability and change, at regional and global scales. These often take the form of sensitivity studies that focus on various aspects of the climate system, including the understanding of feedbacks within the climate system, detection and attribution studies, developing capabilities for decadal predictability, uncertainty characterization, and analysis of feedbacks within the climate system. In essence, RGCM investments are designed to develop metrics for model validation, to conduct climate analysis research in order to inform the model development strategies of Earth System Modeling Program, and to inform the process research priorities within the TES and ASR programs.

The GOAmazon2014 experiment provides a unique opportunity to exercise Regional and Global Models to study interactions among often separated components of the Earth system- the atmosphere and the land. The GOAmazon2014 experiment occurs in a complex location that includes: one of the rainiest regions of the world; an urban heat island; aerosol and pollution sources; and a complex river basin. The Amazon region also has a substantial influence on the large scale circulation through teleconnections. Important research topics for this region include, but are not limited to, the importance of local processes like the interaction of aerosols with clouds and precipitation, processes leading to biases in tropical convection, the influence of land-atmosphere interactions on wet season onset, and the interaction between local and large-scale circulations.

The specific science questions that are the focus of this call are, but are not limited to:

- Enhanced understanding of the interactions between multi-scale processes that relate the local precipitation and hydrological processes to the large-scale climate;
- The relative importance of model resolution, cumulus parameterizations, and land surface in regard to Amazon cloud and precipitation model biases, and remote teleconnections;
- Understanding of how the net primary production (NPP) interacts with radiation, temperature, and precipitation in clean vs. polluted conditions; and
- The relative roles of local and large-scale, both terrestrial and atmospheric influences, on processes controlling diurnal, seasonal, and interannual variability of convection and precipitation.

As part of this FOA, RGCM specifically encourages applications that use a hierarchy of models, ranging from single column models to regional and global models, to conduct and analyze simulations. These models and processes should be evaluated using observations from the GOAmazon experiment and other relevant data sets. The development of metrics that will inform model development is encouraged. The analysis work should also indicate how the work conducted will inform the improvement of the CESM.

### **Collaboration**

Projects funded under this announcement will be affiliated with the multilateral GOAmazon 2014 campaign in Brazil. Selected investigators are expected to coordinate their research with other GOAmazon investigators and with the representatives of the ARM Climate Research Facility. Any planned access to the ARM Mobile Facility or infrastructure support must be approved by and coordinated with the designated ARM site personnel. Applicants should also include in their budget plans to attend the appropriate DOE Principal Investigators meeting for the program most appropriate to the proposed research topic.

This FOA is issued in coordination with funding announcements from the Brazilian state agencies FAPESP and FAPESP. Applications may contemplate collaboration between researchers from DOE/FAPESP only, or DOE/FAPESP only, or DOE/FAPESP/FAPESP. Such collaborations can include e.g. joint or coupled experimental plans, joint analyses of GoAmazon-related data sets, joint analyses of climate models, joint research licenses, student or faculty exchanges, or similar activities. Applicants should list proposed collaborators and describe the collaborative relationships in a section of the project narrative. **Applications for multi-investigator projects must include a clear and well-defined management structure** for integrating collaborating investigators. In addition to Brazilian collaborations, collaborations with other institutions eligible for DOE funding will be considered as appropriate. DOE National Laboratories can participate only as unfunded collaborators.

Collaborations with Amazonian and Sao Paulo investigators: applicants including collaborators applying to the FAPESP (Edital N° 013/2013 – FAPESP {<http://www.fapeam.am.gov.br/edital.php?cod=228>}) and/or FAPESP (COLLABORATIVE RESEARCH IN SUPPORT OF GOAMAZON CAMPAIGN SCIENCE {[www.fapesp.br/chamadas/goamazon](http://www.fapesp.br/chamadas/goamazon)}) announcements should include in the technical

narrative the proposed activities and research plan of the Brazilian members of the team and submit in a separate section the information required in the Brazilian announcement(s). The combined application will also be submitted to FAPEAM or FAPESP according to the instructions in the corresponding announcement. First, each agency will conduct the scientific merit review in accordance with its own procedures and make the prioritization and ranking of proposals previously approved. After these separate reviews, DOE, FAPEAM and FAPESP will jointly consider the merit of the proposals and the interest of each funding agency. Please see section V to see more information regarding DOE's review process.

### **Data Management and Data Sharing Plan:**

Research data obtained through public funding are a public trust. As such, these data must be publicly accessible. To be in compliance with the data policy of the U.S. Global Change Research Program of full and open access to global change research data, **applications submitted in response to this FOA must include a description of the researcher's data sharing plans if the proposed research involves the acquisition of data in the course of the research that would be of use to the climate research and assessment communities.** This includes data from extensive, long-term observations and experiments and from long-term model simulations of climate that would be costly to duplicate. **Explicit data management and data sharing plans are required and should be included as an appendix (i.e., not counted in the page limitation).** The description must include plans for sharing the data that are to be acquired in the course of the proposed research, particularly how the acquired data will be preserved, documented, and quality assured, and where it will be archived for access by others. Data of potentially broad use in climate change research and assessments should be archived, when possible, in data repositories for subsequent dissemination. For DOE projects funded under this FOA, relevant DOE-funded data repositories include CDIAC (<http://cdiac.ornl.gov/>) for TES-related projects, the ARM archive (<http://www.archive.arm.gov/>) for ASR-related projects, and [http://www-pcmdi.llnl.gov/ipcc/about\\_ipcc.php](http://www-pcmdi.llnl.gov/ipcc/about_ipcc.php) for RGCM-related projects.

Applications that include the collection of carbon flux measurements must contribute to the AmeriFlux Network (<http://public.ornl.gov/ameriflux/>) and must specify the nature and timing of data submission to AmeriFlux as part of the data management plan. The establishment of new carbon flux measurement locations will be balanced carefully against the value of existing sites. Potential applicants are encouraged to review the existing AmeriFlux locations and to consider opportunities for collaboration as alternatives to the establishment of new sites. For applications that seek to sustain existing AmeriFlux locations, priority will be placed on hypothesis-based research and sites that have a strong record of measurement performance and prompt delivery of data products to the AmeriFlux archive for use by the broader scientific community. There is an established archive for reporting AmeriFlux data (<http://public.ornl.gov/ameriflux/data-guidelines.shtml>), and supported projects will be expected to comply rigorously with reporting guidelines and standards.

The repository where the researcher intends to archive the data should be notified in advance of the intention, contingent on a successful outcome of the application review. If data are to be archived at the researcher's home institution or in some other location, the application must describe how, where, and for how long the data will be documented and archived for access by

others. Researchers are allowed an initial period of exclusive use of the acquired data to quality assure it and to publish papers based on the data, but they are strongly encouraged to make the data openly available as soon as possible after this period. For this FOA, the exclusive use period is defined to be one year after the end of the data acquisition period for the proposed performance period of the award but exceptions to extend this period may be justified for unique or extenuating circumstances.

**Participation in DOE PI Meetings:**

To ensure that the program meets the broadest needs of the research community and the specific needs of the DOE CESD, lead PIs are expected to attend the annual science team meeting of at least one of the relevant funding programs (TES, ASR, or RGCM). These meetings are 2-4 day meetings held in the Washington, DC area each year. Travel funds should be budgeted to allow at least the lead PI to attend one of these meetings each year. Brazilian collaborators will be invited to these meetings as well, and it is anticipated that travel support for Brazilian collaborators may be available from the appropriate agency or other channels such as the Science without Borders program.

## **Section II – AWARD INFORMATION**

### **A. TYPE OF AWARD INSTRUMENT**

DOE anticipates awarding grants under this FOA. FAPEAM and FAPESP anticipate awarding research grants to eligible collaborating investigators in their respective states.

### **B. ESTIMATED FUNDING**

Research Grant Awards (typically single-investigator projects) are expected to be made for a period of two or three years at a funding level appropriate for the proposed scope, with out-year support contingent on the availability of funds and satisfactory progress. Total DOE funding up to \$2,300,000 annually is expected to be available to support the three program topics in this FOA subject to appropriation of funds by the Congress. DOE is under no obligation to pay for any costs associated with the preparation or submission of an application. DOE reserves the right to fund, in whole or in part, any, all, or none of the applications submitted in response to this FOA.

### **C. MAXIMUM AND MINIMUM AWARD SIZE**

The Floor and ceiling limits apply to individual awards. For collaborative applications to DOE from more than one institution, the following ceiling limits also apply: the DOE-funded team limit is \$350,000 per year for applications addressing only the TES and/or RGCM topics under the section BER Program and Research Topics of Section I, and \$500,000 per year for applications addressing the ASR topics under that section.

The award size for DOE- funded applications will depend on the number of meritorious applications and the availability of appropriated funds.

#### **Ceiling**

\$350,000 per year

#### **Floor**

\$50,000 per year

### **D. EXPECTED NUMBER OF AWARDS**

Approximately 6 to 8 awards are expected. The exact number of awards will depend on the number of meritorious applications and the availability of appropriated funds.

### **E. ANTICIPATED AWARD SIZE**

The award size will depend on the number of meritorious applications and the availability of appropriated funds.

## **F. PERIOD OF PERFORMANCE**

Research Grant Awards are expected to be made for a period of up to three years as befitting the project.

Out-year funding will depend upon suitable progress and the availability of appropriated funds.

## **G. TYPE OF APPLICATION**

DOE will only accept new applications under this FOA.

#### **B. COST SHARING**

Cost sharing is not required.

#### **C. ELIGIBLE INDIVIDUALS**

Individuals with the skills, knowledge, and resources necessary to carry out the proposed research as a Program Director/Principal Investigator are invited to work with their organizations to develop an application for assistance. Individuals from underrepresented groups as well as individuals with disabilities are always encouraged to apply for assistance.

- A cover sheet containing the name and mailing address of the sponsoring institution; the planned title of the research application; the name, e-mail address, and telephone number of the Principal Investigator, additional Senior Investigator(s), and Senior/Key personnel expected to be involved in the planned application. The collaborating Brazilian Principal Investigators and Senior investigators must be identified as from Amazonas or São Paulo, as appropriate.
- An overview of the research plan limited to two pages. Indicate how the proposed research fits into one or more of the research areas described in the Supplementary Information above. List the major research thrusts and the Senior Investigator(s) expected to be involved in the proposed research.
- List the names and institutional affiliations of all participating investigators, including collaborators and consultants on the proposed project. Specifically indicate the collaborators from Amazonas or São Paulo, as appropriate.
- For each funded investigator, a list of collaborative co-investigators including co-authors of past 48 months, co-editors of past 24 months, graduate and postdoctoral advisors/advisees, and close associations.

The LOI must be submitted electronically through the DOE Office of Science Portfolio Analysis and Management System (PAMS) website <https://pamspublic.science.energy.gov/>. It is important that the LOI be a single file with extension .pdf, .docx, or .doc. The Principal Investigator (PI) and anyone submitting on behalf of the PI must register for an account in

PAMS before it will be possible to submit a letter of intent. **All PIs and those submitting LOIs on behalf of PIs are encouraged to establish PAMS accounts as soon as possible to avoid submission delays.**

#### PROJECT NARRATIVE (FIELD 8 ON THE FORM)

The project narrative **must not exceed 20 pages** of technical information, including charts, graphs, maps, photographs, and other pictorial presentations, when printed using standard 8.5” by 11” paper with 1 inch margins (top, bottom, left, and right). The font must not be smaller than 11 point. Merit reviewers will only consider the number of pages specified in the first sentence of this paragraph. Any subsequent pages will be ignored.

Do not include any Internet addresses (URLs) that provide supplementary or additional information that constitutes a part of the application. Using Internet sites in an attempt to avoid page limits will fail: the content of those sites will not be reviewed. References posted to an Internet-based archive or publication are permitted in a list of references. See Part VIII.D for instructions on how to mark proprietary application information. **Background/Introduction:** Explanation of the importance and relevance of the proposed work as well as a review of the relevant literature.

**Timetable of Activities:** Timeline for all major activities including milestones and deliverables.

**Project Objectives:** This section should provide a clear, concise statement of the specific objectives/aims of the proposed project.

The Project Narrative comprises the research plan for the project. It should contain enough background material in the Introduction, including review of the relevant literature, to demonstrate sufficient knowledge of the state of the science. The major part of the narrative should be devoted to a description and justification of the proposed project, including details of the method to be used. It should also include a timeline for the major activities of the proposed project, and should indicate which project personnel will be responsible for which activities.

It is important that the 20-page project narrative section provide a complete description of the proposed work, because reviewers are not obliged to read the last Appendix. Applications exceeding these page limits may be rejected without review or the first 20 pages may be reviewed without regard to the remainder. The page count of 20 does not include the Cover Page and Budget Pages, the Title Page, the biographical material and publication information, or any Appendices, nor does it include the budget pages or special content required by Brazilian agencies.

- What is the past performance of the team?
- How well qualified is the team to carry out the proposed work?
- Are the environment and facilities adequate for performing the proposed effort?

#### REASONABLENESS AND APPROPRIATENESS OF THE PROPOSED BUDGET

- Are the proposed budget and staffing levels adequate to carry out the proposed work?
- Is the budget reasonable and appropriate for the scope?

The combined application will also be submitted to FAPEAM or FAPESP according to the instructions in the corresponding announcement. First, each agency will conduct the scientific merit review in accordance with its own procedures and make the prioritization and ranking of proposals previously approved. After these separate reviews, DOE, FAPEAM and FAPESP will jointly consider the merit of the proposals and the interest of each funding agency.

The evaluation process will include program policy factors such as the relevance of the proposed research to the terms of the FOA and the agency's programmatic needs. ## **E. EVALUATION AND ADMINISTRATION BY NON-FEDERAL PERSONNEL**

In conducting the merit review evaluation, the Government may seek the advice of qualified non-Federal personnel as reviewers. The Government may also use non-Federal personnel to conduct routine, nondiscretionary administrative activities. The applicant, by submitting its application, consents to the use of non-Federal reviewers/administrators. Non-Federal reviewers must sign conflict of interest and non-disclosure agreements prior to reviewing an application. Non-Federal personnel conducting administrative activities must sign a non-disclosure agreement.

## **F. INTELLECTUAL PROPERTY DEVELOPED UNDER THIS PROGRAM**

### **Glossary of Useful Grants and Cooperative Agreement terms**

<b>acquisition cost</b>	The cost of an asset, including the cost to put it in place. When used with equipment (capital expenditure), the term means the net invoice price of property or supplies including cost of modifications, attachments, accessories, or auxiliary apparatus necessary to make the property usable for the purpose for which it was acquired. Other charges, such as the cost of installation, transportation, taxes, duty, or protective in-transit insurance, are included or excluded from the unit acquisition cost in accordance with the recipient's regular accounting practices. It does not include costs for rental of property or alteration and rental of real property.
<b>administrative requirements</b>	The general business management practices that are common to the administration of all grants, such as financial accountability, reporting, equipment management, and retention of records.
<b>allocation</b>	The process of assigning costs to one or more cost objectives, in reasonable and realistic proportion to the benefit provided or other equitable relationship.
<b>allocability</b>	The principle which requires that an expense or service charged must directly benefit and be necessary for the performance of the project; when multiple projects are benefited reasonable proportions must be able to be assigned.
<b>allowable cost</b>	A cost incurred by a recipient that is: (1) reasonable for the performance of the award; (2) allocable; (3) in conformance with any limitations or exclusions set forth in the Federal cost principles applicable to the organization incurring the cost or in the Notice of Financial Assistance Agreement Award as to the type or amount of cost; (4) consistent with regulations, policies, and procedures of the recipient that are applied uniformly to both federally supported and other activities of the organization; (5) accorded consistent treatment as a direct or indirect cost; (6) determined in accordance with generally accepted accounting principles; and (7) not included as a cost in any other federally supported award (unless specifically authorized by statute).
<b>application</b>	A request for financial support of a project or activity submitted to DOE on specified forms and in accordance with DOE instructions. Also known as a proposal
<b>Appropriation Act</b>	The statute that provides the authority for Federal agencies to incur obligations to and make payments out of the U.S. treasury for specified purposes.
<b>approved budget</b>	The financial expenditure plan for the grant-supported project or activity, including revisions approved by DOE and permissible revisions made by the grantee. The approved budget consists of Federal (grant) funds and, if required by the terms and conditions of the award, non-Federal participation in the form of matching or cost sharing. The approved budget specified in the Notice of Financial Assistance Agreement may be shown in detailed budget categories or as total costs without a categorical breakout. Expenditures charged to an approved budget that consists of both Federal and non-Federal shares are deemed to be borne by the grantee in the same proportion as the percentage of Federal/non-Federal participation in the overall budget.
<b>assurance</b>	A certification by an applicant, normally included with the application or State plan, indicating that the entity is in compliance with, or that it will abide by, a particular requirement if awarded a Federal grant.
<b>authorized organizational representative</b>	The individual, named by the applicant organization, who is authorized to act for the applicant and to assume the obligations imposed by the Federal laws, regulations, requirements, and conditions that apply to grant applications or grant awards.

<b>award</b>	The provision of funds by DOE, based on an approved application and budget or progress report, to an organizational entity or an individual to carry out a project or activity.
<b>Bayh-Dole Act</b>	Law which encourages universities and researchers to develop their inventions into marketable products; formal citation is Section 6 of the Patent and Trademark Amendment of 1980, Pub. L 96-517
<b>budget</b>	An estimate of expenditures to be incurred in the performance of a proposed statement of work, or the financial plan or cost assessment for the grant proposal or contract. The budget represents costs associated with project implementation.
<b>budget period</b>	The intervals of time (usually 12 months each) into which a project period is divided for budgetary and funding purposes.
<b>business officer</b>	The financial official of the grantee who has primary fiscal responsibility for the grant. Also known as authorized organizational representative.
<b>carryover</b>	Unobligated Federal funds remaining at the end of any budget period that, with the approval of the Contracting Officer or under an automatic authority, may be carried forward to another budget period to cover allowable costs of that budget period (whether as an offset or additional authorization). Obligated, but unliquidated, funds are not considered carryover.
<b>change in scope</b>	An activity whereby the objectives or specific aims identified in the approved grant application are significantly changed by the grantee after award. Contracting Officer prior approval is required for a change in scope to be allowable under an award.
<b>closeout</b>	The process by which a Federal awarding agency determines that all applicable administrative actions and all required work under an award have been completed by the grantee and the Federal awarding agency.
<b>competitive segment</b>	The initial project period recommended for support (up to 5 years) or each extension of a project period resulting from a renewal award.
<b>conference (domestic or international)</b>	A symposium, seminar, workshop, or any other organized and formal meeting, whether conducted face-to-face or via the Internet, where individuals assemble (or meet virtually) to exchange information and views or explore or clarify a defined subject, problem, or area of knowledge, whether or not a published report results from such meeting.
<b>consortium or subaward agreement</b>	A formalized agreement whereby a research project is carried out by the grantee and one or more other organizations that are separate legal entities. Under the agreement, the grantee must perform a substantive role in the conduct of the planned research and not merely serve as a conduit of funds to another party or parties. These agreements typically involve a specific level of effort from the consortium organization's PD/PI and a categorical breakdown of costs, such as personnel, supplies, and other allowable expenses, including F&A costs. The relationship between the recipient and the collaborating organizations is considered a subaward relationship.
<b>consultant</b>	An individual who provides professional advice or services for a fee, but normally not as an employee of the engaging party. In unusual situations, an individual may be both a consultant and an employee of the same party, receiving compensation for some services as a consultant and for other work as a salaried employee. To prevent apparent or actual conflicts of interest, grantees and consultants must establish written guidelines indicating the conditions of payment of consulting fees. Consultants also include firms that provide professional advice or services.
<b>continuation application/award</b>	A financial assistance request (in the form of an application or progress report) or resulting award for a subsequent budget period within a previously approved project period for which a recipient does not have to compete with other applicants.

<b>contract</b>	An award instrument used to acquire from a non-federal party, by purchase, lease, or barter, property or services for the direct benefit or use of the Federal government. The same term may be used to describe a vendor relationship between a recipient and another party under a grant (to acquire routine goods and services); however, the recipient may use subaward to describe the contract under a grant relationship.
<b>Contract (or Grants Management) Officer</b>	A DOE official responsible for the business management aspects of grants and cooperative agreements, including review, negotiation, award, and administration, and for the interpretation of grants administration policies and provisions. COs and GMOs are delegated the authority to obligate DOE to the expenditure of funds and permit changes to approved projects on behalf of DOE.
<b>Contract (or Grants Management) Specialist</b>	A DOE staff member who works with a contract or grants management officer and is assigned the day-to-day management of a portfolio of grants and/or cooperative agreements. These activities include, but are not limited to, evaluating grant applications for administrative content and compliance with statutes, regulations, and guidelines; negotiating grants; providing consultation and technical assistance to grantees; and administering grants after award.
<b>cooperative agreement</b>	A type of financial assistance used when there will be substantial Federal scientific or programmatic involvement. Substantial involvement means that, after award, scientific or program staff will assist, guide, coordinate, or participate in project activities.
<b>cost principles</b>	The government-wide principles, issued by OMB (or, in the case of commercial organizations, the Federal Acquisition Regulation [48 CFR 21], or, in the case of hospitals, 45 CFR 74, Appendix E, “Principles For Determining Costs Applicable to Research and Development Under Grants and Contracts with Hospitals”), on allowability and unallowability of costs under federally sponsored agreements.
<b>cost sharing</b>	The portion of the costs of a project or program not borne by the sponsor; these could be grantee contributions or third-party in-kind contributions; costs used to satisfy cost sharing requirements are subject to the same policies governing allowability as other costs of the project. Research grants are generally not subject to cost sharing requirements. Also known as matching.
<b>deadline</b>	The published date and/or time that a grant application is to be either postmarked/mailed or electronically submitted to the funding agency.
<b>debarment and suspension</b>	The actions taken by a debarment official in accordance with OMB guidance at 2 CFR 180, “Non-procurement Debarment and Suspension,” to exclude a person or organization from participating in grants and other non-procurement awards government-wide. If debarred or suspended, the person or organization may not receive financial assistance (under a grant, cooperative agreement, or subaward, or contract under a grant) for a specified period of time. Debarments and suspensions carried out pursuant to 2 CFR 376 are distinct from post-award suspension action by an awarding agency.
<b>direct costs</b>	Costs that can be identified specifically with a particular sponsored project, an instructional activity, or any other institutional activity, or that can be directly assigned to such activities relatively easily with a high degree of accuracy.
<b>disallowance</b>	A charge to a grant that the Federal awarding agency determines to be unallowable in accordance with the applicable Federal cost principles or other terms and conditions contained in the award.
<b>domestic organization</b>	A public (including a State or other governmental agency) or private non-profit or for-profit organization that is located in the United States or its territories, is subject to U.S. laws, and assumes legal and financial accountability for awarded funds and for the performance of the grant-supported activities.
<b>DUNS number</b>	A nine-digit number established and assigned by Dun and Bradstreet to uniquely identify a business entity.

<b>effort</b>	The amount of time, usually expressed as a percentage of the total, which a faculty member or other employee spends on a sponsored project. No one is allowed to spend more than 100% total commitment on all academic activities, including grant-sponsored research, university-sponsored research, teaching, administration, advising and other contracted duties. Effort is indicated on the budget in units of person-months.
<b>equipment</b>	An article of tangible nonexpendable personal property that has a useful life of more than 1 year and an acquisition cost per unit that equals or exceeds \$5,000 or the capitalization threshold established by the organization, whichever is less.
<b>expanded authorities</b>	Authorization to grantees under certain research grant mechanisms which waives the requirement for prior agency approval for specified actions related to awards. Example: 90-day preaward spending authority, no cost extensions for up to one additional year, and automatic carryover of unobligated funds from one budget period to the next. The expanded authorities are now contained in the standard terms and conditions for most research grants.
<b>expiration date</b>	Generally, the date signifying the end of the current project period, after which the grantee is not authorized to obligate grant funds.
<b>facilities and administrative costs</b>	Costs that are incurred by a grantee for common or joint objectives and that, therefore, cannot be identified specifically with a particular project or program. These costs also are known as indirect costs.
<b>Federal Financial Report</b>	Submitted on Standard Form (SF) 425, to indicate the status of awarded funds for the period covered. Frequency of reporting is specified in the Reporting Checklist provided as part of the Notice of Financial Assistance Agreement. Replaces the SF-269 Financial Status Report (FSR)
<b>financial assistance</b>	Transfer by DOE of money or property to an eligible entity to support or stimulate a public purpose authorized by statute.
<b>Financial Status Report</b>	See Federal Financial Report.
<b>foreign travel</b>	Foreign travel includes travel outside of the United States and its territories and possessions (Guam, American Samoa, Puerto Rico, the Virgin Islands, and the Canal Zone) and Canada. A trip is considered foreign travel for all legs of the itinerary if the traveler does not return to his or her post prior to departure for a foreign destination. Costs for foreign travel may be restricted by the language of a Funding Opportunity Announcement.
<b>funding opportunity announcement</b>	A publicly available document by which a Federal Agency makes known its intentions to award discretionary grants or cooperative agreements, usually as a result of competition for funds. Funding opportunity announcements may be known as program announcements, requests for applications, notices of funding availability, solicitations, or other names depending on the Agency and type of program. Funding opportunity announcements can be found at <a href="https://www.grants.gov/FIND">Grants.gov/FIND</a> . An FOA may also be known as a solicitation.
<b>grant</b>	A financial assistance mechanism providing money, property, or both to an eligible entity to carry out an approved project or activity. A grant is used whenever DOE anticipates no substantial programmatic involvement with the recipient during performance of the financially assisted activities.
<b>grant-supported project or activity</b>	Those activities specified or described in a grant application or in a subsequent submission that are approved by DOE for funding, regardless of whether Federal funding constitutes all or only a portion of the financial support necessary to carry them out.
<b>grantee</b>	The organization or individual awarded a grant or cooperative agreement by DOE that is responsible and accountable for the use of the funds provided and for the performance of the grant-supported project or activity. The grantee is the entire legal entity even if a particular component is designated in Notice of Financial Assistance Agreement. The grantee is legally responsible and accountable to DOE for the performance and financial aspects of the grant-supported project or activity. Also known as awardee or recipient.

<b>Grants.gov</b>	Grants.gov ( <a href="http://www.grants.gov/">http://www.grants.gov/</a> ) has been designated by the Office of Management and Budget as the single access point for all grant programs offered by 26 Federal grant-making agencies. It provides a single interface for agencies to announce their grant opportunities and for all applicants to find and apply for those opportunities.
<b>indirect costs</b>	See facilities and administrative costs definition.
<b>institutional base salary</b>	The annual compensation paid by an organization for an employee's appointment, whether that individual's time is spent on research, teaching, patient care, or other activities. Base salary excludes any income that an individual may be permitted to earn outside of duties for the applicant/grantee organization. Base salary may not be increased as a result of replacing organizational salary funds with grant funds.
<b>matching or cost sharing</b>	The value of third-party in-kind contributions and the portion of the costs of a federally assisted project or program not borne by the Federal government. Matching or cost sharing may be required by statute or program regulation. Costs used to satisfy matching or cost-sharing requirements are subject to the same policies governing allowability as other costs under the approved budget.
<b>merit (or peer) review</b>	The process that involves the consistent application of standards and procedures that produce fair, equitable, and objective examinations of applications based on an evaluation of scientific or technical merit or other relevant aspects of the application. The review is performed by experts (reviewers) in the field of endeavor for which support is requested. Merit review is intended to provide guidance and to the DOE individuals responsible for making award decisions.
<b>monitoring</b>	A process whereby the programmatic and business management performance aspects of a grant are assessed by reviewing information gathered from various required reports, audits, site visits, and other sources.
<b>no-cost extension</b>	An extension of time to a project period and/or budget period to complete the work of the grant under that period, without additional Federal funds or competition.
<b>non-Federal share</b>	When cost sharing or matching is required as a condition of an award, the portion of allowable project/program costs not borne by the Federal government.
<b>Notice of Financial Assistance Award</b>	The official, legally binding document, signed (or the electronic equivalent of signature) by a Contracting Officer that: notifies the recipient of the award of a grant; contains or references all the terms and conditions of the grant and Federal funding limits and obligations; and, provides the documentary basis for recording the obligation of Federal funds in the DOE accounting system. Also commonly referred to as an Assistance Agreement.
<b>obligations</b>	The amounts for which the recipient has made binding commitments for orders placed for property and services, contracts and subawards, and similar transactions during a funding period that will require payment during the same or a future period.
<b>OMB Circulars</b>	Government-wide guidance issued to Heads of Federal agencies by the Director of OMB. OMB Circulars directly pertinent to grants include the following: <ul style="list-style-type: none"> <li>• cost principles (OMB Circular A-21, OMB Circular A-87, and OMB Circular A-122);</li> <li>• uniform administrative requirements (OMB Circular A-102 and OMB Circular A-110);</li> <li>• audit requirements for non-profit organizations (OMB Circular A-133).</li> </ul> Some (but not all) of these OMB Circulars have been reissued in Title 2 of the Code of Federal Regulations. DOE administrative regulations are located in Title 10 of the Code of Federal Regulations.

<b>Other Significant Contributors</b>	Individuals who have committed to contribute to the scientific development or execution of the project, but are not committing any specified measurable effort (i.e., person months) to the project. These individuals are typically presented at “effort of zero person months” or “as needed.” Individuals with measurable effort may not be listed as Other Significant Contributors (OSCs). Consultants should be included if they meet this definition.
<b>participant</b>	Program participants are the recipients of service or training provided at a workshop, conference, seminar, symposium or other short-term instructional or information-sharing activity funded by an external grant or award, or the training beneficiaries of the project or program funded by an external grant or award. A participant is not involved in providing any deliverable to the grantee or a third party or would not be terminated or replaced for failure to perform.
<b>participant costs</b>	Costs used to pay program participants small stipends and reimbursement of travel costs or other out-of-pocket costs incurred to support attendance at a workshop, conference, seminar, symposium, or other short-term training or information-sharing activity.
<b>person months</b>	The metric for expressing the effort (amount of time) PD/PI(s), faculty and other senior/key personnel devote to a specific project. The effort is based on the type of appointment of the individual with the organization; e.g., calendar year, academic year, and/or summer term; and the organization’s definition of such. For instance, some institutions define the academic year as a 9-month appointment while others define it as a 10-month appointment.
<b>pre-application or pre-proposal</b>	<p>A brief outline or narrative of proposed work and sometimes budget, for informal review by a sponsor to determine whether a full proposal should be submitted. Three predominant reasons for requiring submission of a preliminary proposal are:</p> <ul style="list-style-type: none"> <li>• Reduce the proposers’ unnecessary effort in proposal preparation when the chance of success is very small. This is particularly true of exploratory initiatives where the community senses that a major new direction is being identified, or competitions that will result in a small number of actual awards.</li> <li>• Increase the overall quality of the full submission.</li> <li>• Distill the number of applications that will be submitted to the agency and the number of anticipated reviewers needed to review.</li> </ul>
<b>pre-award costs</b>	Any cost incurred prior to the beginning date of the project period or the initial budget period of a competitive segment (under a multi-year award), in anticipation of the award and at the applicant’s own risk, for otherwise allowable costs.
<b>prior approval</b>	Written approval from the designated Contracting Officer required for specified post-award changes in the approved project or budget. Such approval must be obtained before undertaking the proposed activity or spending DOE funds
<b>Program Director/ Principal Investigator</b>	The individual(s) designated by the applicant organization to have the appropriate level of authority and responsibility to direct the project or program to be supported by the award. The applicant organization may designate multiple individuals as program directors/principal investigators (PD/PIs) who share the authority and responsibility for leading and directing the project, intellectually and logistically. When multiple PD/PIs are named, each is responsible and accountable to the applicant organization, or as appropriate, to a collaborating organization for the proper conduct of the project or program including the submission of all required reports. The presence of more than one PD/PI on an application or award diminishes neither the responsibility nor the accountability of any individual PD/PI.
<b>program income</b>	Program income is gross income earned by a research grant recipient from the activities, part or all of which are borne as a direct cost by the grant. Examples are fees for services performed under the grant, rental or usage fees charged for use of equipment purchased with grant funds, third party patient reimbursements for hospital or medical services paid from the grant, funds generated by the sale of commodities, such as cell

	lines or research animals developed from or paid for from the grant, and patent or copyright royalties.
<b>Program Manager</b>	The DOE official responsible for the programmatic, scientific, and/or technical aspects of a grant. The same role is filled by Program Directors, Program Officers, or Project Directors at other Federal agencies.
<b>progress report</b>	Periodic, frequently annual, report submitted by the grantee and used by DOE to assess progress and to determine whether to provide funding for the budget period subsequent to that covered by the report.
<b>project/performance site</b>	Location(s) of where the work described in the research plan will be conducted.
<b>project period</b>	The total time for which Federal support of a project has been programmatically approved as shown in the Notice of Financial Assistance Agreement; however, it does not constitute a commitment by the Federal government to fund the entire period. The total project period comprises the initial competitive segment, any subsequent competitive segments resulting from a renewal award(s), and extensions.
<b>proposal re-budgeting</b>	See application. Reallocation of funds available for spending between budget categories to allow best use of funds to accomplish the project goals.
<b>recipient renewal application</b>	The organizational entity or individual receiving a grant or cooperative agreement. An application requesting additional funding for a period subsequent to that provided by a current award. Renewal applications compete for funds with all other peer reviewed applications and must be developed as fully as though the applicant is applying for the first time.
<b>research</b>	A systematic, intensive study intended to increase knowledge or understanding of the subject studied, a systematic study specifically directed toward applying new knowledge to meet a recognized need, or a systematic application of knowledge to the production of useful materials, devices, and systems or methods, including design, development, and improvement of prototypes and new processes to meet specific requirements. Also termed “research and development.”
<b>research misconduct</b>	Fabrication, falsification, plagiarism, or other practices that seriously deviate from those that are commonly accepted within the scientific community in proposing, performing, or reporting research, or in reporting research results; does not include honest error or honest differences in interpretations or judgments of data.
<b>SAM.gov</b>	The System for Award Management (SAM) is the Government-wide system that consolidated the Central Contractor Registration (CCR), the Excluded Parties List System (EPLS), the Online Representations and Certifications Application (ORCA), and the Federal Agency Registration (FedReg).
<b>scope of work</b>	The aims, objectives, and purposes of a grant; as well as the methodology, approach, analyses or other activities; and the tools, technologies, and timeframes needed to meet the grant’s objectives. This includes the research or training plan included with the original grant application, along with any approved modifications.
<b>Senior/Key Personnel</b>	The PD/PI and other individuals who contribute to the scientific development or execution of a project in a substantive, measurable way, whether or not they receive salaries or compensation under the grant. Typically these individuals have doctoral or other professional degrees, although individuals at the masters or baccalaureate level may be considered senior/key personnel if their involvement meets this definition. Consultants and those with a postdoctoral role also may be considered senior/key personnel if they meet this definition. “Zero percent” effort or “as needed” is not an acceptable level of involvement for Senior/Key Personnel.
<b>significant rebudgeting</b>	A threshold that is reached when expenditures in a single direct cost budget category deviate (increase or decrease) from the categorical commitment level established for the budget period by more than 25 percent of the total costs awarded. Significant rebudgeting is one indicator of change in scope.

<b>small business concern</b>	A business that is independently owned and operated and not dominant in its field of operation; has its principal place of business in the United States and is organized for profit; is at least 51 percent owned, or in the case of a publicly owned business, at least 51 percent of its voting stock is owned by U.S. citizens or lawfully admitted permanent resident aliens; has, including its affiliates, not more than 500 employees; and meets other regulatory requirements established by the SBA at 13 CFR 121.
<b>solicitation</b>	See Funding Opportunity Announcement
<b>subaward</b>	A legal instrument by which a recipient provides funds (or property in lieu of funds) to an eligible subrecipient (or a lower-tier transaction) to perform a substantive portion of the grant-supported program or project. The term includes such financial assistance when provided by any legal agreement (even if the agreement is called a contract) but does not include any form of assistance which is excluded from the definition of a grant, including the recipient's procurement of property or services needed to carry out the project or program. The term includes consortium agreements.
<b>subrecipient</b>	A party that receives a subaward from a recipient or another subrecipient under a Federal financial assistance award and is accountable to the recipient or subrecipient for the use of the Federal funds provided by the subaward.
<b>supplement</b>	A request for an increase in support during a current budget period for expansion of the project's scope or to meet increased costs unforeseen at the time of the new or renewal application. A supplement may increase support for future years in addition to the current year. Supplements require applications and are subject to administrative and merit review.
<b>terms and conditions of award</b>	All legal requirements imposed on a grant by DOE, whether based on statute, regulation, policy, or other document referenced in the grant award, or specified by the grant award document itself. The Notice of Financial Assistance Agreement may include both standard and special conditions that are considered necessary to attain the grant's objectives, facilitate post-award administration of the grant, conserve grant funds, or otherwise protect the Federal government's interests.
<b>unallowable costs</b>	Specific categories of costs that cannot be charged, directly or indirectly, to federally sponsored agreements in accordance with federal regulations.
<b>unliquidated obligation</b>	For reports prepared on a cash basis, the amount of obligations incurred by the recipient that has not been paid; or For reports prepared on an accrued expenditure basis, the amount of obligations incurred by the recipient for which an outlay has not been recorded.
<b>unobligated balance</b>	The portion of the funds authorized by the Federal agency for expenditure by the recipient that has not been obligated by the recipient.
